The object of the "Association of Marist Brothers" is to promote religious life, the Marist charism and the Marist life for Brothers, and to support the members of the Religious Congregation with due observance of the Constitutions and Regulations of he Religious Congregation. The object is also to promote the Marist charism and Marist life among the lay Marists.</li> <li>2. This object also comprises the promotion of the Christian principles, the evangelization, Marist Spirituality and Christian education, the provision of direct and indirect assistance and resources to the works of the Religious Congregation in the Netherlands and in any other countries, the provision of education and social and religious projects to the Children, Young and Adult people, including the disadvantaged or needy in our society (refugees, minorities, poor communities), as well as supporting projects and persons worldwide, especially in countries and in areas that form part of the Entities of the Religious Congregation. Furthermore, the supervision and support of religious and solidarity projects that have been initiated (in part or in full) by the Religious Congregation in the Netherlands and in any other part of the world, and finally the performance of tasks that may be demanded of the House of Marist Brothers at any time given the circumstances.</li> <li>3. To do everything related to the above or that may be conducive to the above in the broadest sense of the word.</li> </ol>
